

In its capacity as the managing body of Lake Milada Reservoir, the PKÚ has issued the following Rules for Visitors to protect the countryside and landscape and the health and safety of visitors.

RULES FOR VISITORS TO THE LAKE MILADA RESERVOIR

1. Lake Milada Reservoir is open to the public all year round, and entry is free.
2. Vehicles may only enter the reservoir according to the traffic signs and with a valid permit issued by the PKÚ in accordance with the rules for the issue of permits (see www.pku.cz).
3. Swimming is permitted at your own risk at Lake Milada.
4. Engagement in recreational, tourist and sporting activities are at your own risk.
5. All visitors to the Lake Milada Reservoir must obey these Rules for Visitors, the instructions on information boards, public notices and traffic signs. Visitors must obey the requests, instructions or commands of PKÚ security guards.
6. The map of Lake Milada Reservoir and conditions for recreational, tourist and sporting activities constitute an integral part of these Rules for Visitors.

The following activities are prohibited at Lake Milada Reservoir

1. Entering the water of Lake Milada Reservoir in or on any type of motor vehicle.
2. Parking motor vehicles outside the designated parking areas.
3. Entering the water in places not designated for this purpose (beaches and jetties).
4. Diving into the water (danger of injury on the underwater stone wave deflectors).
5. Swimming and diving in places where this may disturb the operation of boats (near anchorage points and moorings).
6. Camping and lighting fires outside the designated locations.
7. Taking dogs onto the beach (with the exception of beaches or sections of beaches designated for this purpose).
8. Damaging and in any way manipulating the technical equipment, floating jetties and eco-jetties.
9. Approaching or climbing onto eco-jetties designed to allow birds to rest and nest.
10. Endangering or restricting other visitors (especially when walking along paths, beaches, jetties or moving around on the water) with your activities or dogs which have been let off their leash.
11. Using motorboats on the lake (with the exception of boats used by the integrated rescue services and lake management).
12. Anchoring or mooring small boats in places not designated for this purpose (see operating regulations for moorings).
13. Entering forest areas on bicycles, roller blades or skis, etc.
14. Fishing and hunting game.
15. Entering forest areas on horseback (with the exception of forest paths), taking horses onto the beach and lakefront paths, and swimming in the lake with horses.
16. Polluting Lake Milada Reservoir with litter.
17. Disturbing the wildlife in any manner, especially with unsupervised dogs allowed off the leash.
